Mayor Jarrod Eno opened the meeting with the pledge of allegiance. LB Perry led with the prayer. A quorum was present with four members present. Proper posting of the meeting was confirmed.

Discuss and Take Action on Canvass Ballots of General Election. Ronnie Funderburk made a motion to accept the Canvass of the Ballots for the Election on May 4,2019. Harley Leazer seconded. Motion carried.

Discuss and Take Action on Swearing in Two Councilmembers. Mayor Jarrod Eno administer the Oath of Office to Brooks Valls and Jimmy Pate. They both took their place at the Council Table.

Discuss and Take Action on Resolution 05132019- Local Sales and Use Tax. The propositions on the Sales Tax increase passed and this resolution will be sent to the comptroller and the new tax rate of 8.25% will go into effect in October 2019. Ronnie made a motion to accept the Resolution. Harley seconded. Motion carried.

RESOLUTION NO. 05132019

A RESOLUTION OF THE CITY COUNCIL OF KOSSE, TEXAS, DECLARING THE RESULTS OF THE CITY OF KOSSE, TEXAS, GENERAL AND SPECIAL ELECTION OF MAY 4,2019

WHEREAS, THE CITY COUNCIL AND MAYOR OF THE CITY OF KOSSE RESOLVED AND ORDERED A GENERAL ELECTION TO BE HELD ON MAY 4, 2019, IN THE CITY OF KOSSE, TEXAS FOR THE PURPOSE OF ELECTING THE FOLLWING:
2 COUNCILMEMBER POSITIONS

WHEREAS, THE CITY COUNCIL AND MAYOR OF THE CITY OF KOSSE RESOLVED AND ORDERED A SPECIAL ELECTION TO BE HELD ON MAY 4,2019 IN THE CITY OF KOSSE, TEXAS FOR THE PURPOSE OF:

THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF KOSSE, TEXAS AT THE RATE OF THREE-EIGHTHS OF ONE PERCENT TO PROVIDE REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS. THE TAX EXPIRES ON THE FOURTH ANNIVERSARY OF THE DATE OF THIS ELECTION UNLESS THE IMPOSITION OF THE TAX IS REAUTHORIZED.

THE ADOPTION OF A SALES AND USE TAX FOR THE PROMOTION AND DEVELOPMENT OF NEW AND EXPANDED BUSINESS ENTERPRISES AT THE RATE OF FIVE-EIGHTHS OF ONE PERCENT.

WHEREAS, THE RETURNS OF SAID ELECTION HAVING BEEN DULY CANVASSED BY THE MAYOR AND CITY COUNCIL, EACH OF THE CANDIDATES IN SAID ELECTION HAVING RECEIVED THE FOLLOWING VOTES TO WIT:

JIMMY PATE	69
DANA "CHICKEN" TAYLOR	47
TRISH ROY	42
SANDRA BALDWIN	5

WHEREAS, THE RETURNS OF SAID ELECTION HAVING BEEN DULY CANVASSED BY THE MAYOR AND CITY COUNCIL, THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF KOSSE, TEXAS AT THE RATE OF THREE-EIGHTHS OF ONE PERCENT TO PROVIDE REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS HAVING RECEIVED THE FOLLOWING VOTES TO WIT:

FOR ADOPTION 82
AGAINST ADOPTION 34

WHEREAS, THE RETURNS OF SAID ELECTION HAVING BEEN DULY CANVASSED BY THE MAYOR AND CITY COUNCIL, THE ADOPTION OF A SALES AND USE TAX FOR THE PROMOTION AND DEVELOPMENT OF NEW AND EXPANDED BUSINESS ENTERPRISES AT THE RATE OF FIVE-EIGHTHS OF ONE PERCENT HAVING RECEIVED THE FOLLOWING VOTES TO WIT:

FOR ADOPTION 83
AGAINST ADOPTION 36

IT IS, THEREFORE FOUND, DECLARED AND ORDERED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KOSSE THAT THE ABOVE ELECTION WAS DULY CALLED. THAT NOTICE OF SAID ELECTION WAS DULY POSTED AND THAT SAID ELECTION WAS HELD IN ACCORDANCE WITH THE LAWS OF THE TEXAS ELECTION CODE. THAT AT SAID ELECTION BROOKS VALLS AND JIMMY PATE WERE ELECTED TO THE TWO AVAILABLE COUNCIL MEMBER POSITIONS. ALL ARE SAID TO BE COUNCILMEMBERS OF THE CITY OF KOSSE SUBJECT TO TAKING THE OATH.

IT IS, THEREFORE FOUND, DECLARED AND ORDERED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KOSSE THAT AT SAID ELECTION THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF KOSSE, TEXAS AT THE RATE OF THREE-EIGHTHS OF ONE PERCENT TO PROVIDE REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS.

IT IS, THEREFORE FOUND, DECLARED AND ORDERED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KOSSE THAT AT SAID ELECTION THE ADOPTION OF A SALES AND USE TAX FOR THE PROMOTION AND DEVELOPMENT OF NEW AND EXPANDED BUSINESS ENTERPRISES AT THE RATE OF FIVE-EIGHTHS OF ONE PERCENT.

SECTION 1: THAT IT IS FURTHER FOUND AND DETERMINED THAT THE RESULTS OF THE ELECTION AS CANVASSED AND TABULATED IN THE PREAMBLE HEREOF REFLECT THE EXPRESSED DESIRES OF THOSE PERSONS VOTING AT SAID ELECTION.

IT IS, THEREFORE FOUND AND DETERMINED THAT IN ACCORDANCE WITH THE LAWS OF THE TEXAS ELECTION CODE, THE CITY SECRETARY POSTED WRITTEN NOTICE OF THE DATE, PLACE AND SUBJECT OF THIS MEETING ON THE BULLETIN BOARD LOCATED AT THE CITY OFFICE, A PLACE CONVENIENT AND READILY ACCESSIBLE TO THE GENERAL PUBLIC AND SAID NOTICE HAVING BEEN SO POSTED AND REMAINED POSTED CONTINUOUSLY FOR AT LEAST 72 HOURS PRECEDING THE SCHEDULED TIME OF SAID MEETING.
