Discussion and take action on Proposed Tax Rate for 2022-2023. Kendall Funderburk made a motion to propose a lower tax rate than last year's rate. The proposed tax rate is .5698/\$100. Cullen Freeman seconded. Motion carried.

Discussion and take action on Propose 2022-2023 Fiscal Year Budgets - W/S and General Fund. Todd Freeman made a motion to propose both 2022-2023 W/S and General Fund budgets that were worked on in the budget workshop. Kelli Eno Seconded. Motion carried.

Charles Dickerson gave the Water report. Produced 1.8 million gallons. We are in stage 2 of the Drought Contingency Plan, doesn't see a need to go to stage 2 at this time. HE has repaired 4 leaks. One more leak will be repaired Thursday at 10:00 am. Water may go off, if it does everyone is under a boil order notice. Kendall told Charles to buy tools, there is \$1000 left in the budget.

City Secretary Christina Lockhart gave the City/Court Report Court is next week.

Police Chief Brett New gave the PD Report. 74 tickets. New Officer is Gregg Lewis. He was an officer at Beverly Hills near Waco. Part-time and will move to full-time. Received the check reimbursement for the window insert. A new windshield is \$2995.00 and we have received funds from a grant to cover the new windshield.
