signing above and 2) signing this section to request Deferred Disposition – this means 2 signatures are required) Deferred Disposition is a period of probation that last 90 days. Upon successful completion of all the probation requirements ordered by the Court, a Defendant's case will be dismissed and a final conviction will not be reported on the Defendant's record. To qualify for Deferred Disposition a Defendant cannot have a Commercial Driver's License (CDL) and have not committed their violation within a construction work zone. Defendants must contact the Court to request Deferred Disposition for speeding offenses over 25 mph and for any other violations such as No Insurance (FMFR) and Driving While License Invalid (DWLI).

The required Deferred Disposition payment for all speeding offenses up to 24 mph over and other moving violations is \$50.00 more than the fine amount, which will need to be paid at the end of the Deferral Period and sent back with affidavit.

requesting the Court to grant me Deferred Disposition in my case(s).
